

Subject **Mayoral Appointments to Aging and Disability Services Advisory Council**

The Aging and Disability Services Advisory Council is a volunteer citizens group which represents older adults and individuals with disabilities within our community. The Advisory Council's mission is to identify the needs of older people and adults with disabilities, to give advice on services to meet these needs, and to advocate for local, state and national programs that promote quality of life for these populations. The Council was authorized by the Older Americans Act of 1965. Local authority for appointments is set forth in the inter-local agreement (11/2000).

The Advisory Council consists of 27 members who are appointed by three sponsors: City of Seattle (9), King County (9), and United Way (9). The nine (9) City of Seattle members are appointed by the Mayor and confirmed by the City Council. Attached to this memorandum is the current membership roster of the Aging and Disability Services Advisory Council including the new appointees.

The appointments' bios for the appointees are as follows:

Diane Snell

Ms. Snell received her Masters of Social Work degree from the University of Washington. Working as a medical social worker in Group Health's Home Health and Hospice Programs, she has been involved in aging issues and services for many years. In her work with the Home Health Program assisting homebound patients, she became aware of local resources and the unmet needs of older adults in our community. Her involvement with issues facing older adults extends to her personal life as well. She recently began a highly successfully "Senior Focus" program at her church to help meet a need among older church members. As a grandparent raising a grandchild she has been active in Grandparents Re-Parenting for many years. Ms. Snell is active with the Leschi Community Council and is editor of the Leschi News. She also serves on the board of the Central Area Senior Center.

Duong Nguyen

Mr. Nguyen received his Master of Social Work (MSW) degree from the University of Wisconsin and his Bachelors of Art in Social Welfare (BASW) degree from the University of Washington. He currently serves as Director of Providence Peter Claver House, a not for profit organization (sponsored by Providence Health & Services) providing supportive housing for low-income seniors in South Seattle's New Holly neighborhood. He has been involved in non-profit, diversity education and community organizing for some time and is currently an active member of various community councils and committees in South Seattle. Before returning to Seattle, Duong served as Director of Youth Development and Interim Executive Director of Freedom, Inc., a non-profit organization in Madison, Wisconsin with a focus on domestic violence advocacy and youth development. While pursuing his undergraduate degree and working as Resident Manager for Youth Care's Home of Hope Transitional Housing Program, Duong, along with two of his classmates, created and facilitated a 400-level course focusing on diversity, social identities, and oppression. Duong's initial interest in community work and social services was sparked by his experience serving as Community Commissioner for the Office of Diversity & Retention at South Seattle Community College. He is currently pursuing his license to become a foster parent. In his spare time, Duong enjoys spending time with his family, exercising his husky, and engaging in recreational activities such as snowboarding, long-boarding, canoeing, and kayaking.

Claire Brannan

Ms. Brannan graduated from the University of Washington with a Bachelors of Science Degree. She worked with mentally ill teens and children, and then changed careers to work with seniors. She spent the past ten years dedicated to improving the lives of seniors and those living with disabilities. During that time, Claire worked as a social worker in several nursing facilities, and owned and operated two dementia specialty adult family homes. Four years ago Claire created her own business, Mobile Classes and Consulting. Her goal was to educate organizations that provide long term care and

people who receive those services. Her programs continue to be successful and reach hundreds of individuals who now give better care after taking classes ranging from dementia to fire prevention.

Molly Holmes

Molly Holmes graduated from Central Washington College in 1948. She continued her post graduate work for three years while working for the weekly Quincy Valley Post Register a publication she co-founded. After finishing her studies, she taught special education for 23 years (20 in the Seattle area) and also acted as substitute principal. Once retired, she spent ten years operating a community thrift store. During that time the shop revenue increased from \$6000 annually to \$60,000 annually. She now volunteers for Habitat for Humanity locally and abroad and continues to make annual trips to Guatemala and Honduras to build houses for local communities.
