The Historic Seattle PDA is an organization created in 1975 in accordance with SMC 3.110. The PDA Council has twelve members, four of whom are appointed by the Seattle Mayor, four of whom are appointed by existing PDA Council members, and four of whom are appointed by the PDA's constituency. All appointments to the PDA Council are confirmed by the Seattle City Council.

Mr. Sever is an architectural historian and general contractor whose background with Historic Seattle goes back to 1991 when he joined the organization as a volunteer. He was appointed to the Council in 2003. He co-founded Historic Seattle's "Preserving Your Old House" program and has served on the Development, Audit, and Executive Committees of the Council, and served as Chair of the organization in 2008 and 2010. More recently he has become active on the Historic Seattle Foundation Board. Mr. Sever's longterm dedication to the goals and activities of Historic Seattle have served the organization well and we anticipate his valuable involvement in the four years to come.

Mr. Sever was reappointed by the Historic Seattle Constituency at their meeting of 1/23/12 at the Neptune Theater. His term, succeeding will last until 11/30/15.
