**NOTICE OF CITY COUNCIL PUBLIC HEARING ON PROPOSED
MULTI- PURPOSE ARENA LOCATED IN SEATTLE'S SODO NEIGHBORHOOD**

The City Council is considering legislation that would adopt a Memorandum of Understanding (MOU) between the City of Seattle, King County, and ArenaCo, a private company. This MOU would constitute a binding commitment of the City to work with the other two parties to develop a new multi-purpose sports and entertainment facility at First Avenue South and South Massachusetts Street. The arena would be designed to host both a National Basketball Association team and a National Hockey League team, as well as other events. The proposed amount of the City's capital commitment to the project is \$120,000,000. Because the proposed arena is a City-Private Partner Project as defined in Resolution 31203, this public hearing satisfies the requirements of Section 5 of that resolution.

The City Council's Government Performance and Finance Committee will hold a public hearing to take comments on the proposal on **Thursday, July 19, 2012, in the Bertha Knight Landes room, 1st floor**, Seattle City Hall, 600 Fourth Avenue. **The meeting begins at 5:30 p.m.**
