

Tanya is a civil engineer and owns a local consulting company called Jimale Technical Services. Before founding JTS, Tanya managed various projects in the Puget Sound and Seattle metropolitan area. She was project coordinator/manager on various public works projects, transit facilities, and land acquisition and development projects.

In the early phase of JTS, Tanya provided technical assistant to help the Mt. Zion Baptist Church build a 65 unit a low-income independent senior citizen facility.

While as the consultant serving as executive director for the City of Seattle's Central Area Public Development Authority, Tanya managed a US Department of Housing grant called Hope II where this was a feasibility study and environmental plan to convert an existing multifamily apartment into affordable housing where existing rental families would purchase a condominium unit as first time home owners.

Key iconic attributes include:

- Tanya is a member of the Iota Phi Lambda, Inc. Beta Kappa Chapter, Seattle since 1994.
- The first African-American woman to graduate from the University of Washington's School of Civil Engineering in 1982.
- In 1993, Tanya started her own business and now employees a staff of 14.
- In 2007, the City of Seattle selected JTS to receive the Mayor's Small Business Award.
- Seeing small businesses succeed is one of her passions. She has also been recognized for her willingness to help those in the community achieve work and education goals they may have otherwise found insurmountable, by helping at-risk youth and individuals who need job skills training and real-world work.
- In October 2010, Tanya was recommended by the City of Seattle Mayor's Office to be one of three woman-owned small businesses to participate in a "Backyard Chat" with President Barack Obama on a visit to Seattle.
- In 2012, Tanya is 1 of 5 finalist to receive the Nellie Cashman business women of the year recognition by the Women Business Owners organization of greater Puget Sound Region.

Tanya is an active participant in many civic and neighborhood organizations that promote growth, and has also received numerous awards for her involvement and her support and advice to other small and minority-owned businesses. Tanya has great stories to share about how success followed when she nurtured her business, her employees and her community at the same time. She is an accomplished speaker and willing to share stories on the struggles and successes to create and build a business.
