In 1994, Barry formed Lorig Management Services (LMS), a Washington partnership between his Oregon firm and Lorig Associates, a Seattle-based real estate development company. Barry served as President of LMS until 2011, when he left to form his new firm, Blanton Turner.</p> <p>Blanton Turner is a regional real estate management company led by Barry and his partners Heidi Turner, Chasten Fulbright, Alan Byars and Krista Janes-Blackburn. Blanton Turner has offices in Seattle and Eugene, Oregon. Blanton Turner specializes in the management of urban mixed-use properties, student housing properties, and provides consulting and marketing services for new developments and property lease-ups.</p> <p>Barry served as the 2010 President of the Western Washington Chapter 27 of the Institute of Real Estate Management, and was named Chapter 27 Certified Property Manager of the Year for 2009. In addition, Blanton Turner manages a portfolio of properties for the University of Washington, and consults with real estate developers on programming, marketing, lease-up and operating new developments in the Pacific Northwest.
