<b>Background:</b> <p>Karen Yoshitomi is the regional director for the Japanese American Citizens League (JACL), a national nonprofit organization whose mission is to secure and protect the civil rights of Japanese Americans and all others against discrimination and injustice. The JACL also works to preserve and promote the culture and history of the Japanese American community. Since its inception in 1929, the organization has maintained a presence in the Seattle Chinatown International District.</p> <p>Ms. Yoshitomi has been with the JACL since 1990, and as the key spokesperson for the organization within the Pacific Northwest region, she is responsible for administration and implementation of national programs, assisting the local chapters, and providing outreach and support within the broader community. Ms. Yoshitomi has also been involved with the development of the Japanese Cultural and Community Center of Washington since 2004 and is currently serving as the chair of its Community Advisory Council.</p> <p>When Ms. Yoshitomi was initially appointed to the SCIDpda Council she was completing the term of a Council Member. This reappointment should be considered her first full term of serving on the SCIDpda Council.</p>





### 1. Call to Order

The meeting was called to order by Mike Omura at 5:30 pm

### 2. Mission Moment

Michael Yee talked about an event held on November 17, 2012 at which time a kiosk was presented honoring Filipino Americans in Chinatown International District from 1911 to 2010, and spoke of the history that led to the establishment of the kiosk. It is located at 6<sup>th</sup> and King Street.

### 3. Items Requiring Council Action/Approval

### 4. Management Report

Vern Wood briefed the Council about October revenue and operating expenses and talked about some of the items reflected in the management reports.

Michael Yee talked about activities leading to the 2013 ID Spring Roll, and reported that Jennifer Phang and Karen Yoshitomi have again agreed to co-chair the ID Spring Roll Committee. He also indicated that they are looking for more Committee members. Michael noted that most of the activities for ID Spring Roll are done by staff and that the only requirement will be to attend committee meetings. Sponsorship letters will begin to be sent out. Discussion followed about sponsorships and Michael talked about pricing of the tickets for the 2013 ID Spring Roll.

Joyce Pisanonot briefed the Council about IDEA Space activities and reported that there had been a rash of break-ins to local shops in the last 1.5 months. Discussion followed about what Council members can do to get SPD to take more preventive actions. Council members would like to send a letter to Mayor McGinn and the SPD to encourage more visibility of law enforcement in the CID. Kip Tokuda talked about the importance of organized advocacy.

In the interest of time, Maiko advised the Council that her Director's Report was included in their Council packet.

**5. Presentation – 2013 Budget**

David Chang thanked Vern Wood and staff, senior management, and Council members Scott Yasui, Karen Yoshitomi, Kip Tokuda and Mike Omura for their work on the 2013 budget. He asked Vern to brief the Council about the proposed budget.

Vern reviewed the budget and clarified information as questions were asked by Council members. As questions were posed, discussion followed. Mike Omura, who attended the November Finance Committee meeting at which time the 2013 was presented to the Committee, said that as a non-financial person the budget was presented in a way which was better to understand. Further discussion continued about the proposed budget.

**d. Resolution 12-12-12-04:** We, the Seattle Chinatown International District Preservation and Development Authority Council, approve the 2013 Budget.
