

Since joining the West Seattle Helpline, we have increased our funding by close to 20% and expanded all of our program operations.

As the Development and Event Coordinator for Avivara, I worked on such components as web design, strategic planning, fundraising, donor relations, and community organizing. Through this position I also focused on community outreach by connecting with 8 disadvantaged communities to distribute resources such as school supplies, food, and clothing. As a result of planning and implementing Avivara's first large-scale fundraising event, I was able to accomplish the goal of securing over \$23,000 in donor contributions for this grass-roots organization.

Some of my accomplishments include coordinating 150 volunteers for a one-day school restoration project, implementing a one-day service project with 350 university student volunteers, planning and leading a group of 10 professionals on a week-long New Orleans volunteer trip, traveling to 6 different states to promote community service programming and conduct workshops at Universities, and co-implementing the Student Volunteer Leadership Curriculum which has been published by Hands On Network.

As a second grade teacher I taught all subjects at a Title One inner city school in a self-contained English Language Development classroom.
