

1. Why do you want to become a member of the Seattle Youth Commission? I want to become a member of the Seattle Youth Commission for many reasons, the most prominent being my desire to be involved in local government. I have strong feelings about some policy topics and would love the opportunity to share them. I also thoroughly enjoy discussions about policy and government, and would enjoy talking to other youth about the issues in local government today.

2. What issues are you passionate about in your community, and why? One of the issues I feel strongly about in my community is public transportation. As someone who has spent the last year and a half living on public transportation, it is an issue that I'm extremely passionate about, and also one that I feel is being poorly dealt with. Having spent a week in Olympia with the Senate Page Program, I have seen how hard it is to confront these issues on the State level, and thus I believe we must deal with them in local government. I am also very passionate about education issues, such as standardized testing and teacher pay and education. Personal experiences with over-testing and teachers with less-than-ideal knowledge of their subject drive this zeal.

3. What are your greatest strengths, and in what areas would you like to improve? I believe my greatest strength is my ability to work well with others. Working on my youth group's board has really helped me grow in this area. Planning events and writing programs are tasks that require multiple people, and finding a common vision or idea with my peers is something I've attained from my experiences. Another strength of mine is my love of intellectual argument. While I enjoy thinking and writing about topics and issues, debate has always been my favorite way to fully examine them. I believe that it is key to explore and consider all points of view before forming a full opinion, and my work with the Mock Trial team has been a fantastic experience that has definitely supplemented my growth here. An area that I still see room for me to grow is my passion for things I'm not "passionate" about, so to speak. For things that interest and entice me, work ethic will never be an issue. However, when I'm not interested or enticed by the subject, I don't always put my full effort in to it. Working on the Seattle Youth Commission would definitely help me to improve my work ethic, no matter the topic.

4. As a Youth Commissioner, you'll spend a lot of time working in groups. What's your most comfortable role in a group? My most comfortable role in a group is the "interpreter". Analyzing and critiquing data comes easily to me, and I work best in this capacity. My accolades in Mock Trial, such as the "Outstanding Attorney" award, help to demonstrate my analytical skills. A major part of being an Attorney for Mock Trial is taking data, interpreting it, and then presenting in a way that favors your client. I have been able to transfer this skill to regular class discussions, like in my Business class, where I've succeeded in analyzing cases for health and auto insurance, as well as applications for home and car loans.
