ORDINANCE _____
COUNCIL BILL 117805

AN ORDINANCE relating to the City Light Department; accepting various easements for overhead and underground electrical rights in King County, Washington; placing said easements under the jurisdiction of the City Light Department; and ratifying and confirming certain prior acts.

WHEREAS, the Department of Planning and Development requires that applications for short plats, lot boundary adjustments, and unit lot subdivisions be reviewed by other City departments as a condition of its approval of such property divisions; and

WHEREAS, it is the intention of both the Department of Planning and Development and the City Light Department that each lot created by such property divisions has adequate access for utilities including electrical service; and

WHEREAS, after review by the City Light Department, the Department of Planning and Development places City Light easements in gross on final approved short plats, lot boundary adjustments, and unit lot subdivisions when necessary to ensure adequate electrical service access; and

WHEREAS, the Seattle City Charter, Article IV, Legislative Department,, Section 14, Powers by Ordinance; Fourth, Acquisition and Disposal of Property, requires that all acquisition and disposal of real property interests shall be by ordinance; NOW, THEREFORE,

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. The City hereby accepts the easements for overhead or underground electrical distribution rights upon, under and across the real property in King County, Washington, as more particularly described in the short plats, lot boundary adjustments, and unit lot subdivisions granted by the following persons or entities in 2012 and identified as follows:

17 ratified and confirmed.

18 Section 4. This ordinance shall take effect and be in force 30 days after its approval by
19 the Mayor, but if not approved and returned by the Mayor within ten days after presentation, it
20 shall take effect as provided by Seattle Municipal Code Section 1.04.020.

Legislation Title:

AN ORDINANCE relating to the City Light Department; accepting various easements for overhead and underground electrical rights in King County, Washington; placing said easements under the jurisdiction of the City Light Department; and ratifying and confirming certain prior acts.

Summary of the Legislation:

This legislation accepts easements for electrical overhead and underground distribution rights, acquired through the Department of Planning and Development's land use permitting in 2012.

Background:

The Department of Planning and Development (DPD) requires that applications for short plats, lot boundary adjustments, and unit lot subdivisions be reviewed by other City departments as a condition of approval for these land use applications.

City Light engineers review these applications and determine the necessary easements to provide future electrical service. DPD then includes these easements in the land use documents. These easements are acquired at no expense to the City.

City Light submits legislation which accepts these easements, acquired through DPD's land use permitting, on an annual basis. This legislation accepts 103 easements from the property owners listed therein.

b) What is the financial cost of not implementing the legislation?

City Light cannot provide electrical service for these customers without these easements in place. The financial cost of not implementing this legislation would be the foregone revenue of these customer accounts.

Yes, this legislation accepts on behalf of the City of Seattle electrical easements conveyed to the City in short plats, lot boundary adjustments, and unit lot subdivisions previously approved by the Department of Planning and Development.
