Councilmember Burgess,

I am forwarding to the City Council an annual report of all real property under City ownership. We update this information each year to avoid holding properties without an adopted municipal purpose. The annual review supports strategic management of the City's real estate holdings.

Each January, FAS initiates the annual review process. City departments with jurisdiction over real property assure that all recent acquisitions and/or dispositions are accurately represented, and provide current information about each property's current use, future use, if identified, and the level of utilization (classification) for each property.

As of March 22, 2013, the City had ownership interests in 1,209 property management areas. (There are additional property management areas where the City may have only a leasehold interest, easement or other property right). Per the Procedures, each property is classified based on its level of utilization -- from Fully Utilized Municipal Use to Surplus.

City needs change over time, so the annual review is intended to keep up to date the status of all City-owned real property and create opportunities to find the best municipal use of each property or put it back into the private sector.

CITY REAL PROPERTY HOLDINGS

City Council Resolutions 29799 and 30862 provide guidance on strategic real property management for all City property. The City's goal in adopting policies and procedures through these resolutions was to strategically utilize real property in order to further the City's goals and to avoid holding properties without an adopted municipal purpose. City needs change over time, so the annual review is intended to keep up to date the status of all City-owned real property.

City properties are primarily identified by a unique Property Management Area (PMA) number. Each PMA represents property that is self-identified by a City department as a management unit, e.g., a facility, park, community garden, reservoir or other discrete area serving a specific departmental function. PMA's are under the jurisdiction of different departments within the City according to the use of the PMA. PMA's may overlap, e.g., a community garden may be sited underneath an electric transmission line with an agreement between departments.

While the bulk of City property is owned in fee simple, the City also leases or obtains easement interests when appropriate. Agreements with other public agencies provide another type of property right, e.g., the Seattle School District and Department of Parks and Recreation have agreements which provide for mutual use of certain parks and playgrounds. There are over 1,500 total PMA's in the citywide Real Property Asset Management Information System, RPAMIS, administered by the Department of Finance and Administrative Services.

As of March 22, 2013, the City had ownership interests in 1,209 PMAs. It is these PMA's that the annual update addresses. Per the Procedures, each property is classified based on its level of utilization -- from Fully Utilized Municipal Use to Surplus (definitions are provided in Table 1).

Each January, FAS initiates the annual review process whereby City departments with jurisdiction over real property provide current information about real property holdings, including current use, future use, if identified, and changes in classification for each property. The report (Table 2) provides a breakdown of the number of owned PMAs by department jurisdiction, by different types of ownership, and by classification.

STATUS	DEFINITION
Fully Utilized Municipal Use Property	Municipal Use Property that is actively being used for municipal purposes to the fullest capacity possible under any required restrictions on its Municipal Use.
Underutilized Property	Municipal Use property that could support additional and/or more intensive uses without interfering with the primary use of the property.
Interim Use	The use of property for a non-municipal use(s) on a short-term basis during the period of time prior to its being used for its proposed future Municipal Use.
Unused Property	Property owned by the City that is not currently in Municipal Use and that is not being rented, leased, or otherwise used under an agreement with the City.
Excess Property	Real Property that the Jurisdictional Department has formally determined it no longer needs for the Department's current or future use.
Surplus Property	Excess Property formally designated by the City Council as not needed to carry out any recognized goal or policy of the City.
