Background: Ivan is a licensed psychologist, and an academic in the department of Rehabilitation Medicine at the University of Washington. For the past 6 years he has worked directly with individuals with medical disabilities who are seeking care in hospital clinics. He works with clients on a variety of psychological and social work issues, ranging from psychological adjustment to new physical disability (e.g., depression or anxiety) to more practical issues around every day living (e.g., returning to work or making workplace accommodations, managing transportation, etc.). He works directly with a team of other rehab professionals, including speech pathologists, physicians, occupational and physical therapists and vocational rehabilitation counselors, and has a good broad understanding of the issues that affect individuals with physical and neurocognitive disabilities. He is deeply involved in the disability research community at the local and national levels, and has given several talks to advocate for disability/aging services to representatives of federal agencies (including the Administration for Community Living, and the U.S. Department of Education). Although he is able bodied, he feels that he has a good understanding of the kinds of issues that face people living with a disability in the city of Seattle and looks forward to applying his skills to improve their experience.
