

Background: <p><i>Dr. Marie Wong is an Associate Professor in the Institute of Public Service at Seattle University and teaches courses in Urban Planning, Housing and Sustainability, and Asian American History and Community Development. She earned her Bachelor's degree in Community and Regional Planning from Iowa State University and a Master of Planning and Community Development from the University of Colorado. Her Ph.D. is in Urban Design and Planning from the University of Washington with major study in American Urban and Architectural History and Chinese American History with a certificate in Preservation Planning and Design. Prior and amid her 22 year teaching career, she has over 25 years of experience in public and private sector planning practice in Colorado, California and Washington. She began serving on boards and committees in the Chinatown-International District in 1989 including exhibit committees with the Wing Luke Museum of the Asian Pacific American Experience and completed five years of service on the board of InterIm Community Development Association. She currently serves on the Board of Directors of the Kong Yick Investment Company. Her scholarship and writing focuses on Asian American community history and the cultural manifestation of design in the built environment. She is author of Sweet Cakes, Long Journey: The Chinatowns of Portland, Oregon. (2004, 2012) and numerous articles and book reviews. Most recently, Dr. Wong completed a book manuscript entitled Home "Below the Line" which chronicles the history of single room occupancy residential hotels and Asian American community development in Seattle's Chinatown-International District.</i></p>
