COUNCIL BILL 118193

AN ORDINANCE relating to the City Light Department; amending subsection 21.49.086.D of the Seattle Municipal Code to create Net Wholesale Revenue targets for 2015 and 2016 consistent with those assumed in the City Light 2015-2020 Strategic Plan adopted by Resolution 31529.

WHEREAS, the City established the City Light Rate Stabilization Account ("RSA") within the Light Fund in part to buffer the City Light Department and its rate payers from shortfalls in the amount of Net Wholesale Revenue actually earned relative to that specified in budgets and assumed in electricity rates; and

WHEREAS, Ordinance 123260 provided a funding mechanism for the RSA and established rules for its operation, including a formula for computing the target level of Net Wholesale Revenue for the purpose of developing budgets and retail electricity rates, and for determining deposits to, and withdrawals from, the RSA; and

WHEREAS, Ordinance 123989 changed the methodology for computing the Net Wholesale Revenue target, eliminating the formula and establishing specific dollar amount targets for 2013 and 2014 consistent with those assumed in the City Light 2013-2018 Strategic Plan adopted by Resolution 31383; and

WHEREAS, the City Light 2015-2020 Strategic Plan, adopted by Resolution 31529, assumes specific targets for Net Wholesale Revenue for the years 2015 to 2020, and electricity rates consistent with those targets; and

WHEREAS, the City Council intends to adopt retail electricity rates for 2015 and 2016 that are consistent with those in the 2015-2020 Strategic Plan; and

WHEREAS, the City Council will reconsider spending plans, the targets for Net Wholesale Revenue, and the retail electricity rates to support them for subsequent years as part of the update and extension of the Strategic Plan in 2016; NOW, THEREFORE,

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. Subsection 21.49.086.D of the Seattle Municipal Code, last amended by Ordinance 124108, is amended as follows:



1 Section 2. This ordinance shall take effect and be in force 30 days after its approval by
2 the Mayor, but if not approved and returned by the Mayor within ten days after presentation, it
3 shall take effect as provided by Seattle Municipal Code Section 1.04.020.

Legislation Title:

AN ORDINANCE relating to the City Light Department; amending subsection 21.49.086.D of the Seattle Municipal Code to create Net Wholesale Revenue targets for 2015 and 2016 consistent with those assumed in the City Light 2015-2020 Strategic Plan adopted by Resolution 31529.

Summary of the Legislation:

This ordinance establishes City Light Net Wholesale Revenue targets for 2015 and 2016 that are consistent with those assumed in the City Light 2015-2020 Strategic Plan adopted June 30, 2014 by Resolution 31529.

Background:

The City established the City Light Rate Stabilization Account (RSA) within the Light Fund in part to buffer the City Light Department and its rate payers from shortfalls in the amount of Net Wholesale Revenue (NWR) actually earned relative to that specified in its budgets and assumed in its electricity rates. In March of 2010, Council adopted Ordinance 123260 which provided a funding mechanism for the RSA and established rules for its operation, including a formula for computing the target level of NWR for the purpose of developing budgets and retail electricity rates, and for determining deposits to, and withdrawals from, the RSA.

In 2012, Council adopted the City Light 2013-2018 Strategic Plan (Resolution 31383) which included more conservative NWR targets than the historical average originally determined by Ordinance 123260. The more conservative revenue targets reflected changing market and resource conditions which indicated that future NWR was likely to be significantly lower than historical levels, and served to reduce the likelihood of future RSA surcharges thereby providing rate payers with improved rate stability. Ordinance 123989 effected these changes, and established NWR targets for 2013 and 2014 which were consistent with the Strategic Plan and the adopted 2013 and 2014 electricity rates.

This proposed legislation establishes NWR targets of \$65 million for 2015 and \$60 million for 2016. These values are consistent with the new Strategic Plan Update for 2015-2020 and the electricity rates proposed for 2015-2016, which are in the accompanying legislation.

Revenue/Reimbursement Notes:

Changing the NWR target affects the likelihood of triggering automatic RSA retail rate surcharges, but does not change anticipated revenues. This legislation establishes NWR targets that are about \$5 million lower than the Department's market-based forecast of NWR, which implies that there should be a low (but not zero) probability of RSA surcharges triggered in the coming biennium. Note that the new target is also incorporated in the 2015-2016 proposed rates.

 Not passing this legislation would mean there would be no 2015 or 2016 NWR target. The NWR target is critical to the financial operation of the RSA and the surcharge decision procedures established by Ordinance 123260. The RSA would be unusable.

Dear Council President Burgess:

I am transmitting the attached proposed Council Bill, amending subsection 21.49.086.D of the Seattle Municipal Code to establish Net Wholesale Revenue targets for 2015 and 2016 which are consistent with the City Light 2015-2020 Strategic Plan adopted June 30, 2014 by Resolution 31529.

The City established the City Light Rate Stabilization Account (RSA) within the Light Fund in part to buffer the City Light Department and its rate payers from shortfalls in the amount of Net Wholesale Revenue actually earned relative to that specified in budgets and assumed in electricity rates. In March of 2010, Council adopted Ordinance 123260 which provided a funding mechanism for the RSA and established rules for its operation.

In July of 2012, Council adopted Ordinance 123989, which established conservative targets for Net Wholesale Revenue for 2013 and 2014 that were consistent with the assumptions in the City Light 2013-2018 Strategic Plan, adopted by Resolution 31383. Similarly, this proposed legislation establishes Net Wholesale Revenue targets for 2015 and 2016 that are consistent with the recently adopted 2015-2020 Strategic Plan update, and the accompanying legislation to adopt 2015 and 2016 electricity rates.

These proposed changes to the Net Wholesale Revenue target will reduce the likelihood of future RSA surcharges, providing our customers with a high degree of rate stability. Should you have any questions, please contact City Light Finance Director Paula Laschober at 206-684-3168.
