## Aly Pennucci Day

**WHEREAS,** Aly Pennucci has served on the Seattle City Council Central Staff for over 9 years and at the City of Seattle for over 11 years; and

WHEREAS, During that time Aly has demonstrated a true commitment to the City through her leadership, shaping high-performing teams, improving overall culture, and building connections and collaborations across departments and organizations to strengthen the foundational fabric of our City; and

WHEREAS, Aly worked her way from Senior Planning & Development Specialist in the Department of Planning and Development (now the Seattle Department of Construction and Inspections) to Central Staff Legislative Analyst, Public Policy & Budget Manager, and finally Deputy Director; and

WHEREAS, Aly facilitated transformative legislative changes to the timeliness and usefulness of budget information available to the legislative branch, through her work on creating the independent Office of Economic and Revenue Forecasts and the Fiscal Transparency Program; and

WHEREAS, Aly has served as a reliable thought partner, trusted counselor, mediator, and problem-solver in countless ways, and was a stabilizing presence and helped maintain operations during the transition of two Central Staff Directors; and
