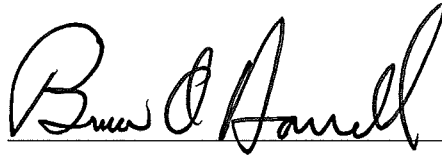
BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. Payment of the sum of \$28,142,559.15 on PeopleSoft 9.2 mechanical warrants numbered 4100013031- 4100016639 plus manual or cancellation issues for claims, E- Payables of \$68,776.71 on PeopleSoft 9.2 9100000146 - 9100000179 and Electronic Financial Transactions (EFT) in the amount of \$33,686,365.58 are presented for ratification by the City Council per Chapter RCW 42.24.180.

Section 2. That any act consistent with the authority and prior to the effective date of this ordinance is hereby ratified and confirmed.

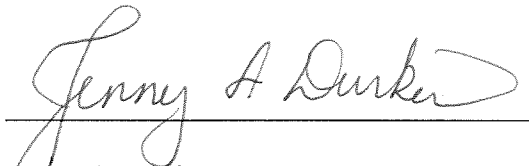
1 Section 3. This ordinance shall take effect and be in force 30 days after its approval by

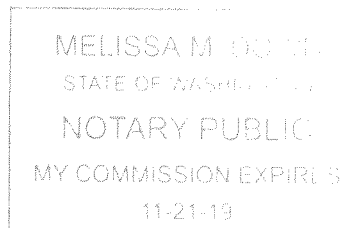
