ORDINANCE NO. 4012

AN ORDINANCE providing for the holding of a special election in the city of Seattle for the purpose of choosing fifteen resident freeholders thereof to prepare a new charter for the government of said city.

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. That on the 10th day of December, 1895, in the City of Seattle, County of King and State of Washington, pursuant to the provisions of section 10 of article XI of the constitution of the State of Washington and an act of the legislature of the State of Washington, entitled "AN ACT to authorize cities of the first class to alter, change, revise, add to or repeal their respective charters," approved March 4, 1895, there shall be held a special election in said city for the election of fifteen resident freeholders of said city, who shall have been residents of the city of Seattle for a period of at least two years preceding their election and are qualified electors of said city, whose duty it shall be to prepare a new charter for said city by altering, changing, revising, adding to or repealing the existing charter of said city, together with any amendments thereto, as provided in said act of the legislature.

Section 2. That no person shall be eligible to election as a freeholder, as herein provided, unless he shall have been a resident of said city for at least two years preceding his election and who is not at the time of his election a qualified elector of said city and a resident freeholder therein.

Section 3. It shall be the duty of the persons elected at said election to convene within ten days after their election and within

sixty days thereafter prepare a new charter for said city by altering, changing, revising, adding to or repealing the existing charter of said city, together with any amendments thereto, and to file the same with the city clerk, who shall cause said new charter to be published in two daily newspapers of said city for at least thirty days prior to the time of submitting the same to the electors of said city for their ratification or rejection.

Section 4. That after the filing of said new charter with the city clerk and the publication of the same as provided in section 3 of this ordinance, the city council shall provide for the submission of said new charter to the qualified electors of said city for their ratification or rejection.

Section 5. The city clerk shall give ten days notice of the election of freeholders as herein provided, (which notice shall specify the object of calling said election) by posting a notice in each election precinct in said city and by causing the said notice to be published in full in the official newspaper of said city during said period.

Section 6. The following places are hereby designated for the purposes of said election as the places of voting in the several election precincts in the several wards of said city, namely:

In the first precinct of said ward, northeast corner of Jackson street and Railroad avenue.

Section 7. The following persons are hereby respectively appointed inspectors, judges and clerks of election for the several places of voting designated in and by section 6 of this ordinance in the several election precincts of the several wards of said city at said election mentioned in this ordinance, provided, however, that the appointment of clerks of election hereby made is and shall be subject to be controlled by the appointment of the same or other clerks at said several precincts respectively by the inspectors and judges of election appointed herein for each such precinct, as they may determine and appoint before the time of opening the polls at said election as provided by law, to-wit:
