A RESOLUTION adopting the Seattle City Council 2016 Work Program.

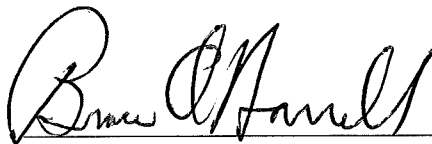

GENERAL OVERSIGHT OF CITY AUDITOR

Ongoing oversight of City Auditor function.

PACIFIC PLACE GARAGE

Review financial performance and any forthcoming proposals regarding ownership and operations of the garage.

Review and consider action on anticipated Limited Tax General Obligation (LTGO) bond sales and issuance of miscellaneous debt. Attend and monitor monthly Debt Management Policy Advisory Committee (DMPAC) meetings.

QUARTERLY BUDGET AMENDMENTS AND YEAR-END LEGISLATION

Review budget-related legislation including supplemental requests, grant acceptance, carry-forward, capital abandonment, fund closure, exceptions, and other ordinances.

REAL ESTATE EXCISE TAX (REET) BUDGET AND CITYWIDE REVENUE UPDATES AND FORECASTS

Review and consider quarterly revenue updates and forecast information. Brief Councilmembers as appropriate. Evaluate any new revenue proposals.

FAS will work with the Council on a review and assessment of credit card and other payment options for constituents needing to make payments to the City. This review may take into consideration implementation costs, ongoing transactional costs, efficiencies for both customers and City staff along with internal controls. This review will look at simple payments as well as more complex payments that require special handling.

Review and adopt the 2016 Update to the Consolidated Plan.

Consider potential changes to the MFTE Program consistent with Housing Affordability and Livability Agenda (HALA) recommendations. Review annual report on MFTE program.

Monitor implementation of Central District Cultural District, work toward defining and identifying future arts districts, and consider affordability for cultural commercial spaces.

Monitor public access television (Seattle Community Media).

CHINATOWN-INTERNATIONAL DISTRICT (ID) AND LITTLE SAIGON SMALL BUSINESS

Monitor the progress of the organization(s) receiving funding to provide assistance to the small business community. Support the Ethnic Business Coalition's design and implementation of strategies that will mitigate tenant vacancies in Chinatown-ID.

CITY CONTRACTING POLICIES AND PRACTICES

Review City contracting policies and practices, including requirements and technical assistance for women and minority owned enterprises, priority hiring, etc.

CITYWIDE BUSINESS ADVOCACY TEAM

Review annual report of Citywide Business Advocacy Team and seek recommendations for better promotion.

COMMERCIAL RENT CONTROL

Review and provide policy direction as needed - including consideration of other ways to help preserve and assist small businesses - regarding the Executive's response to Statement of Legislative Intent #149-1-A-3 related to the regulation of commercial property rents in Seattle.

COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) FLOAT LOANS AND SECTION 108 LOANS

Review and consider approval of proposed Section 108 loans and possible CDBG float loans. Monitor Section 108 loan pool via quarterly and annual reports, and review recommendations, if any, to strengthen Section 108 policies.

Review recommendations of the Economic Development Commission.

ECONOMIC OPPORTUNITY CENTER

Review the Executive's proposal to lift the proviso described in Green Sheet #16-1-A-1 related to funding for pre-development of the Southeast Seattle Economic Opportunity Center.

EFFORTS TO CORRECT ECONOMIC DISPARITIES

Monitor City efforts to identify effective approaches to asset building; job training in key sectors such as technology, restaurants, biotech, and life sciences; access to banking and other financial services; educational attainment; family support; access to health care, healthy foods, and other ways to address historic trends in disparities.

INTERNATIONAL BUSINESS DEVELOPMENT

Monitor and review the Office of Economic Development (OED)'s work related to (1) identifying countries and industries to focus international business development activities; (2) creating country-specific foreign direct investment strategies and (3) align organizational missions of the Trade Development Alliance, Economic Development Council, Washington State China Relations Council, and Washington Council on International Trade.

MANUFACTURING AND INDUSTRIAL SUPPORT

Monitor land use efforts to strengthen protections for industrial lands, particularly for Port-related and other maritime uses. Monitor Stadium District recommendations. Review Puget Sound Regional Council (PSRC) report on Industrial Lands. Consider recommendations to improve manufacturing workforce development. Review implications of new Seaport Alliance between Seattle and Tacoma Ports.

MISCELLANEOUS ECONOMIC DEVELOPMENT ISSUES

Review and monitor economic development-related legislation including but not limited to City nightlife ordinances, talent and job development initiatives, and business capacity in neighborhood districts.

NEIGHBORHOOD BUSINESS DISTRICT SUPPORT

Monitor and examine implementation of the Only in Seattle program and consider expanding neighborhood business district priorities and programs in 13 neighborhoods.

NEIGHBORHOOD EQUITABLE TRANSIT ORIENTED DEVELOPMENT INITIATIVE (NET)/DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT (HUD) COMMUNITY CHALLENGE GRANT

Monitor implementation of initiative to help stabilize businesses around the Othello Station in Southeast Seattle and to acquire key sites for mixed-use projects that incorporate affordable residential units and dedicated small business and community space.

NEW MARKETS TAX CREDIT (NMTC) PROGRAM AND OTHER LENDING PROGRAMS

Participate in the Committee that makes decisions regarding allocation of NMTCs. Review annual report on NMTC program.

PRIORITY HIRE

Monitor implementation of the Priority Hire program.

WORKFORCE DEVELOPMENT AND HIGHER EDUCATION POLICIES AND INVESTMENTS

Review the Office of Economic Development's ongoing policy and programmatic work in workforce development. Advocate for provision of financial empowerment services for those accessing training/educational services. Continue to explore development of higher education/skill/entrepreneurial training center in Southeast Seattle.

WORKFORCE DEVELOPMENT COUNCIL WORKFORCE ECOSYSTEM PROJECT

Pursuant to 2015 SLI 15-1-A-1, review OED's report of the organizational assessment study ("Workforce Ecosystem Project") conducted by the Workforce Development Council.

DRAINAGE AND WASTEWATER FUND ISSUES

Address Drainage and Wastewater Fund issues including rates, combined sewer overflow program, stormwater code update, green stormwater infrastructure, utility purchase of service related to transportation and other City functions, capital program implementation, grant acceptance, land transactions, and state and federal stormwater requirements.

PRIVATE PROPERTY IMPACTS

Monitor and address impacts to private property related to aging drainage infrastructure.

SUPERFUND

Continue to monitor efforts to assess and manage potential liabilities and clean-up activities at several sites in the City, including the Duwamish River. 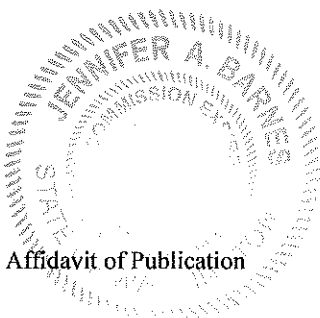

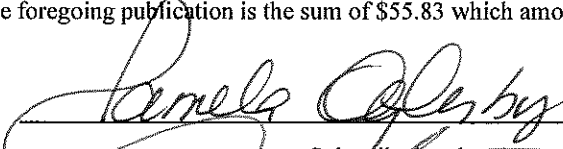

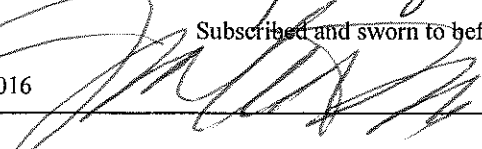
